Government's Roadmap Out of Lockdown in England:

On 14.6.21 the government announced the final Stage of their roadmap to lifting restrictions in England would be delayed until 19th July, to enable more vaccines to be administered and help reduce the chance of further lockdowns. New 'We Offer Testing to Our Staff' (WOTTOS) Scheme Launched:

The WOTTOS endorsement scheme is a simple and free voluntary promotional scheme for businesses offering rapid workplace testing to staff, either through on-site testing or workplace test collection. The scheme showcases those organisations that offer regular testing for their employees through displaying an easily recognisable and NHS Test and Trace branded physical and/or virtual sticker. Businesses will be able to download posters and stickers on the Test Ordering Platform to demonstrate their offer for free, regular testing to their employees keeping people safe. Asymptomatic COVID-19 Testing for All Registered Businesses: (Registration Closed)

All registered businesses in England can benefit from asymptomatic COVID-19 testing, for employees who are unable to work from home. This scheme closed on 12th April, but **businesses who registered before** 12th April can still order free home test kits until 19th July 2021. To order test kits please click here

Test & Trace Support Payment Scheme:

A £500 payment is available to those eligible who have been told to self-isolate by NHS Test and Trace or are the parent or guardian of a child who has been told to self-isolate. To view the eligibility criteria please click here

Self-Employed:

- Self-Employment Income Support Scheme The government has extended this scheme:
 - First Grant (Closed) A taxable grant of 80% of average monthly profits over the last three years, up to £2500 per month, for at least three months and could be claimed whilst continuing to do business.
 - Second Grant (Closed) A taxable grant of 70% of average monthly profits, capped at £6,570
 - Third Grant (Closed) A taxable grant of 80% of average profits up to £7,500. For businesses
 continuing to actively trade but faced reduced demand due to coronavirus. This grant covered
 three months' worth of profits for November 2020 to end of January 2021.
 - Fourth Grant (Closed) A taxable grant of 80% of 3 months average profits up to £7,500 to cover February to end of April 2021 for businesses impacted during this period, causing significant reduction in trading profits for their reporting year.
 - Fifth Grant (Online Claims Service opening late July) A taxable grant of 3 months average trading profits to cover May to September:
 - Turnover reduced by 30% or more to receive 80% of 3 months average trading profits
 - Turnover reduced by less than 30% to receive 30% of 3 months average trading profits
 - 600,000 businesses who were previously excluded due to being new start-ups can now apply if they filed a tax return by midnight on 2.3.21

You can claim if you're self-employed or a member of a partnership and all of the following apply:

- you traded in the tax year 2018 to 2019 and submitted your Self-Assessment tax return on or before 23 April 2020 for that year
- you traded in the tax year 2019 to 2020
- o you intend to continue to trade in the tax year 2020 to 2021
- o you carry on a trade which has been adversely affected by coronavirus.

You must make the claim yourself and not your tax agent or adviser on your behalf. To check their eligibility and apply please <u>click here</u>

- Childcare Support Protection Working parents who are on the Government's coronavirus support schemes will still be eligible for childcare support even if their income falls below the minimum threshold requirement. Eligible working parents who receive support through the Government's extended Self-Employed Income Support Scheme (SEISS) will continue to receive their childcare entitlements, including the 30 hours offer and Tax-Free Childcare, even if their income levels fall below the threshold temporarily whilst on these schemes. - **Deferred Self-Assessment Income Tax Payments** Self-assessment taxpayers will now be able to benefit from a separate additional 12-month extension from HMRC on the "Time to Pay" self-service facility, meaning payments deferred from July 2020, and those due in January 2021, will now not need to be paid until January 2022.
- **Universal Credit** Can now be accessed in full by the Self-Employed (up to £1,800 per month for eligible people in rented accommodation) Further information on this support is available here
- Coronavirus Business Interruption Loan Scheme (Closed) This scheme closed on 31.3.21 and was open to the Self-Employed. For further info please <u>click here</u>. To view advice on what to do if you have claimed too much and do not plan to make another claim please <u>click here</u>

For All Businesses:

- Recovery Loan Scheme (Now open until 31st December 2021) A loan scheme for businesses of all sizes from £25,000 to £10mil, with a lender's government guarantee up to 80%. For further information please click here
- Traineeship Employer Incentive £1000 cash boost to help employers take on new trainees and Apprenticeships. Available until 31st July 2021. For further information please click here
- Coronavirus Job Retention Scheme-
 - From the 1st July 2021 the government will pay 70% of wages up to a maximum cap of £2187.50 for the hours the employee is on furlough. Employers will top up employees' wages by 10% to make sure they receive 80% of wages (up to £2,500) in total for the hours the employee is on furlough. The caps are proportional to the hours not worked.
 - This scheme will run until 30.9.21
 - Businesses will have flexibility to use the scheme for any amount of time employees do not work, shift patterns and full-time furloughing.
 - HMRC will now reimburse a sliding scale of wage costs for 'furloughed' worker's hours not worked (workers who have been asked to stop working but have not been made redundant) with employers expected to start contributing 20% in August and September.
 - Employers can claim for an employee even if the employer has not claimed for them before. This applies for employees on the payroll on or before 30th October 2020. The employer must have made a PAYE Real Time Information (RTI) submission to HMRC between 20 March 2020 and 30 October 2020, notifying a payment of earnings for that employee.
 - Claims must be submitted by 11.59pm 14 calendar days after the month you are claiming for.
 If this time falls on the weekend or a bank holiday, then claims should be submitted on the next working day:
 - June 2021 must claim by 14th July 2021
 - Scheme is live on the HMRC website. To claim and read further information please <u>click here</u>
- Additional Restriction Grant (ARG) (Round 5 Open) The 5th round of the ARG discretionary grant is open for applications until 30th June 2021. This grant is available to all businesses who could demonstrate financial loss as a result of the pandemic and are not covered by other grant schemes or where additional funding is required. - Employees Tax Relief for Working from Home From 6.4.20 Employers can pay employees up to £6 a week tax free to cover additional costs if they have had to work from home. Eligible taxpayers can claim tax relief based on the rate at which they pay tax. For further information please <u>click here</u>

- Kickstart Scheme Employers can now deal directly with the government without needing 30 vacancies. Employers will get £1,500 per job placement for 16- to 24-year-olds on Universal Credit who are at risk of long-term unemployment, along with 100% of minimum wage for 25 hours per week for 6 months and employer NIC and pension contributions.

- Scaling up of HMRC 'Time to Pay' offer- All businesses and individuals who are in temporary financial distress as a result of COVID-19 and have outstanding tax liabilities please contact HMRC's dedicated helpline: 0800 0159559 for advice on this offer. Please note that you will need to pay interest if you pay late. You may avoid penalties by contacting HMRC as soon as possible. For further info please click here
- Corporate Insolvency and Governance Bill (Ends on 30th June 2021) A series of measures to amend insolvency and company law to support business to address the challenges resulting from the impact of Coronavirus (COVID-19). The Bill consists of 6 insolvency measures and 2 corporate governance measures. The insolvency measures will provide vital support to businesses to help them through this period of instability. Measures have been extended by The Corporate Insolvency and Governance Act 2020 (2020 No. 1349) until 30th June 2021. For the Bill press release click here

- Future Fund (Closed) Application deadline closed on 31.1.21. This was a 50% match-funded convertible loan facility, for unlisted UK registered companies that have raised at least £250,000 in equity investment, from third party investors in the last 5 years. Loans of £125,000 to £5mil were available. For further information please click here
- Local Restrictions Support Grant (Now Closed) (Closed Addendum- Tier 4, National Lockdown & Closed Business Lockdown Payment)

 — Registration deadline was 31.5.21. These three grants were dealt with under one application for businesses who have been mandated to close and are registered for business rates. The person/business registered for business rates could receive:
 - Funding for an additional 44 days to cover the period 16th February to 31st March 2021, for businesses mandated to close. Adur & Worthing Councils contacted companies who had already submitted claims under the LRSG (Closed Addendum) scheme. Please note, eligible companies who have had not submitted any claims to LRSG (Closed Addendum) needed to complete a registration form.
 - Properties with a rateable value of £15,000 or less received £476 for the Tier 4 restrictions,
 £2,001 for the National Lockdown and £4,000 for the Closed Business Lockdown Payment
 - Properties with a rateable value over £15,000 and less than £51,000 received £714 for the Tier 4 restrictions, £3,000 for the National Lockdown and £6,000 for the Closed Business Lockdown Payment
 - Properties with a rateable value of exactly £51,000 or more received £1,076 for the Tier 4 restrictions, £4,500 for the National Lockdown and £9,000 for the Closed Business Lockdown Payment (Up to £25,000 for exceptional circumstances)

- Adur & Worthing Self-Isolation Grants (Closed) £500 taxable lump sum payment for employees on low incomes who have been instructed to self-isolate by NHS Test & Trace and meet the government eligibility. This is in addition to SSP. This scheme ran from 28th September to 31st January 2021. For further information please click here
- **Deferred VAT (Closed)** The Online Payment Service closed on 21st June 2021 This gave businesses the option to pay deferred VAT in equal instalments, interest free and choose the number of instalments, from 2 to 11 (depending on when they join) Further details <u>click here</u>
- Deferred Self-Assessment Tax Payments If you delayed making your second payment on account normally due on 31st July 2020 due to Coronavirus, this was added to your tax bill due on 31st January 2021. For further info please <u>click here</u>

- Job Support Scheme (Deferred until after Furlough ends)
 - For Open Businesses Was due to start on 1st November and run for 6 months. For the first 3 months employees working 20% of their normal hours would receive 61.67% government funding (up to £1,541.75 per month) to match with 5% employer funding (up to £125 per month) for hours not worked. This support was to be available to employers even if they have not previously used the furlough scheme. After 3 months the government was planning to consider whether to increase the minimum working hours threshold. To read the scheme factsheet please click here.  - For Businesses Required to Close as a Result of Coronavirus Restrictions This scheme was expanded to provide a £3,000 grant to pay wages of staff who cannot work and two thirds of each employee's salary (or 67%) up to a maximum of £2,100 a month. Further information please click here
- Job Retention Bonus (Deferred until after Furlough ends). A one-off payment to employers of £1,000 for every employee who they previously claimed for under the Coronavirus Job Retention Scheme, and who remains continuously employed through to 31 January 2021. Eligible employees must have earned at least £520 a month on average between the 1 November 2020 and 31 January 2021. Employers would have been able to claim the Job Retention Bonus after 15th February 2021. For further information please click here

Small Businesses with Up To 10 Employees:

 Adur & Worthing Council's Small Business Growth Grant Scheme- (Closed) Grants of up to £2,500 were available, with a 50% match funding contribution required (exclusive of VAT). These grants aimed to encourage growth and expansion of the local economy, leading to new employment opportunities. To view the grant guidance please <u>click here</u>

Small Businesses with Low / Exempt for Business Rates:

• Small Business Grant Scheme- (Closed) A one-off £10,000 grant was available to help meet ongoing business costs, for all small businesses in England already receiving Small Business Rate Relief. To view an overview of the grant please click here and the grant guidance please click here

Small Businesses with up to 50 Full Time Equivalent Employees:

- Government Trade Credit Insurance £10 Billion Guarantee (Closes on 30.6.21) Businesses with supply chains which rely on Trade Credit Insurance and who are experiencing difficulties maintaining cover due to Coronavirus will get support from the government. To read more please <u>click</u> here
- Adur & Worthing Council's Apprentice Grant (Closed) A one off payment of £1,000 per apprentice was available towards the cost of taking on an apprentice. Individual businesses could apply for up to two grants. To view the grant guidance please click here
- Bounce Back Loan Scheme (Closed) Businesses who had borrowed less than the lower of £50K or less than 25% of their turnover, could top-up their existing loan Payment extended to up to 10 years with new 'Pay as You Grow' flexible repayment system. Interest-only periods of up to six months and one 6-month payment holiday was also available to businesses. This scheme was aimed at helping small and medium-sized businesses (up to 50 employees) to borrow between £2,000 and £50,000. The government guaranteed 100% of the loan and there are no fees or interest to pay for the first 18 months. Loan terms were up to 10 years. No repayments will be due during the first 12 months and a loan fixed interest rate of 2.5%. For information please click here
- Coast to Capital Backing Business Grant (Closed) This was a £2 million fund set up to provide grants of £5,000 £25,000 to independent small businesses and social enterprises who have been affected by COVID-19. This grant was designed to help businesses to either adapt, evolve, or innovate their business to offset the impact of the pandemic. Due to an overwhelming response this fund has now closed.

• Top-Up to Local Business Grant Funds Scheme – (Closed) Adur and Worthing Councils received 142 grant applications for Round 1 of this discretionary fund. Round 1 & 2 have now closed, and businesses notified of the outcome of their application. This discretionary fund was aimed at small businesses previously outside the scope of the business grant funds scheme, with less than 50 employees, who could demonstrate a significant drop in income due to Coronavirus restriction measures and provided help with ongoing fixed property-related costs. There were three levels of grant payments £25,000, £10,000 and local authorities had discretion to make payments of any amount under £10,000. Adur & Worthing Councils adopted the West Sussex Councils' Discretionary Fund Guidelines to provide a fair and standardised approach to this discretionary fund.

SME's: (less than 250 staff and an annual turnover under £45mil)

- Business Hot House Programme Programme specifically focuses on improving business leaders' knowledge to increase productivity and innovation, designed to support the majority of micro, small and medium-sized enterprises, as well as entrepreneurs who are developing pre-trading ideas. This includes six packages of strategic support designed to help you survive and thrive, delivered by expert business support providers that can make a real difference to your business. ERDF funding is available to pay for 12 hours of any of the sessions. For further information please click here
- Help To Grow The government's new Help to Grow Management programme offers the chance to
 take your business to the next level. Join other senior business leaders in a practical management
 training programme, with 1-1 mentorship, delivered across the UK. The 12-week programme costs
 just £750 and is 90% subsidised by the government as part of its Plan for Jobs to help businesses to
 drive growth and create jobs. This is aimed at senior leaders of small and medium businesses. For

- Statutory Sick Pay Rebate Scheme Advice Advice has been added to this scheme enabling employers to request confirmation that the employees need to isolate. Employees do not have to provide a doctor's fit note for you to make a claim. But you can ask them to provide either:
 - An <u>isolation note from NHS 111</u> if they are self-isolating and cannot work because of coronavirus (COVID-19)
 - A 'shielding note' or a letter from their doctor or health authority advising them to shield because they're at high risk of severe illness from coronavirus

- Reclaiming Statutory Sick Pay- Businesses with less than 250 employees (as of 28 February 2020 on all of their payroll schemes) can now check to see if they can use the Coronavirus Statutory Sick Pay Rebate Scheme. Businesses can reclaim Statutory Sick Pay (SSP) for staff sickness absence due to COVID-19, for up to 2 weeks. (£94.25 per week before 6.4.20 and now £95.85 per week) Employers can request that employees provide an isolation note from NHS 111 or a 'shielding note', or a letter from their doctor or health authority. - Invest4 Business Hot House Funding Programme Businesses with less than 250 employees can apply for a grant from £2,000 to £170,000 (40% of project costs) to help support growth of their business. For further info please click here
- Restart and Recovery SME Grant (Closed) Applications have now closed for Coast to Capital
 Growth Hub's additional funding round. The scheme offered grants of between £1000 £3000 (up to
 £5000 for exceptional circumstance) to provide professional services to help businesses adapt during
 the COVID-19 pandemic or to purchase new equipment. 100% of the money came from government
 with no obligation for businesses to contribute financially. For further info please click here
- Business Recovery Grants (Closed) Due to the unprecedented level of Expressions of Interest (EOIs) for funding, Coast to Capital Growth Hub have now closed the Business Recovery Grants Scheme. This £2.1 million grant scheme provided up to 50% of an expansion project for organisations that could demonstrate a clear link to COVID-19 recovery and growth, with funding of between £10,000 and £170,000 (for projects of £20,000 to £340,000). • Coronavirus Business Interruption Loan Scheme (CBILS)- (Closed) - Payment extended to up to 10 years. All major banks offered access to working capital of up to £5mil for up to 10 years. For further info please click here

Large Businesses:

- Coronavirus Large Business Interruption Loan Scheme (CLBILS) (Closed). All viable businesses with a turnover of more than £45mil could apply for up to £200mil of finance and businesses with a turnover over £250mil could apply for up to £50mil of finance. For further information click here
- COVID-19 Corporate Financing Facility (CCFF): (Closed) The CCFF will continue to provide
 finance for firms with outstanding loans in the scheme until March 2022 at the latest. The Bank of
 England bought short-term debt to support businesses who had been affected by a short-term funding
 squeeze, to enable the finance of short-term liabilities. To qualify the business must have had a short
 or long-term rating of investment grade as of 1st March 2020, or equivalent. Also, the business will
 need to:
 - o be considered as making a material contributing to UK economic activities
 - have their headquarters based in the UK
 - have been incorporated in the UK (including those with a foreign-incorporated parent company)
 - Other factors

- Local Restrictions Support Grants for Tier 2/3 Open Businesses (Suspended) due to the 6.1.21 national lockdown. This grant was for businesses that had not been mandated to close but have been severely impacted due to Tier 2/3 restrictions. For further information please click here
- Local Restrictions Support Grants for Tier 2/3/4 Closed Businesses (Suspended) due to the 6.1.21 national lockdown. This grant was for businesses who were mandated to close due to Tier 2,3 or 4 restrictions. For further information please click here

Retail, Hospitality & Leisure:

- Restart Grant Scheme- For high street businesses:
 - o Non-essential retail granted up to £6,000 per premises
 - Hospitality, Leisure, Gyms and Personal Care granted up to £18,000 per premises

- Business Rates Holidays- (Ends 30th June 2021) Retail, hospitality and leisure businesses who pay business rates in England, received a Business Rates Holiday for the 2020 to 2021 tax year and this has been extended until 30th June 2021 for eligible property types. This will then be discounted by 2/3rd for the rest of the year, up to £2mil for closed businesses and a lower cap for those trading. No action is required as the qualifying business rates bills will reflect this change. For eligibility information please click here
- Hospitality & Leisure 5% VAT (Closed) Extended until 30th September 2020, followed by 12.5% until April 2021
- Cash Grants- (Closed) England based businesses with occupied business rateable property such as shops, cafes, hotels etc will receive funding of up to £25,000. For businesses with a property of a rateable value:
 - Under £15,000 received a grant of £10,000
 - o Between £15,001 and £51,000 received a grant of £25,000

This scheme offered grants of between £1000 - £3000 (up to £5000 for exceptional circumstance) to provide professional services to help businesses adapt during the COVID-19 pandemic or to purchase new equipment. 100% of the money came from government with no obligation for businesses to contribute financially. Consumers:

- FCA Confirms Further Support for Motor Finance & High Cost Credit Customers The Financial Conduct Authority (FCA) announced an extension to the targeted temporary measures implemented to assist with motor finance, buy-now pay-later, rent-to-own, high-cost short term credit and pawnbroking agreements. Those who have not yet had a payment deferral will be eligible for 2 payment deferrals of up to 6 months in total and those who currently have an initial payment deferral, will be eligible for a further payment deferral of up to 3 months. Firms will also continue to offer tailored support to overdraft borrowers which could include:
 - o reducing or waiving interest
 - o agreeing a programme of staged reductions in the overdraft limit

- FCA Confirms Temporary Financial Relief for Customers Impacted by Coronavirus The FCA announced an extension of payment deferrals on loans and credit card payments, along with mortgage payment holidays to include:
 - Those who have not yet had a payment deferral will be eligible for 2 payment deferrals of up to 6 months in total
 - Those who currently have an initial payment deferral, will be eligible for another payment deferral of up to 3 months
 - Those who have resumed repayments after an initial payment deferral will be eligible for another payment deferral of up to 3 months
